\*\* Estimate number of Uninsured is based on an analysis of the 2013 American Community Survey that was conducted by the Colorado Health Institute and independently used by Connect for Health Colorado. The number of uninsured is calculated by taking the number of uninsured individuals, by county, who are between the ages of 19-64 and eligible for tax credits (FPL of 138%-400%, including those over 400% FPL). The number of total covered lives through Connect for Health Colorado (as of 2/28/15), by county, was then subtracted from the estimated number of uninsured individuals to approximate the number of remaining uninsured.
