After the end of this open enrollment period, enhancements and upgrades were applied to the technological infrastructure of the organization, as well as the Customer Service Center. A Shared Eligibility System was implemented enabling a single online application to determine if a person qualifies for Medicaid or Child Health Plan Plus coverage, or qualifies for a tax credit to lower the cost of private insurance through Connect for Health Colorado. Connect for Health Colorado continued to develop strategies to achieve sustainability after federal See continuation on Schedule O
