RE: Integration of the formulary look-up tool

Dear Members of the Board,

On behalf of the Chronic Care Collaborative (CCC), we want to thank you for the meeting we had with Connect for Health Colorado (C4) staff in April regarding the prescription drug formulary look-up tool.

We want to thank the Board and the staff of C4 for the significant work that has been done to better the shopping experience and increase transparency in health insurance costs. We encourage further improvements for transparency of health insurance costs by fully integrating the formulary look-up tool, including plan-specific cost sharing information, into the shopping experience.

Shopping for health insurance is complicated, especially for someone living with a chronic condition who must weigh many factors when picking a plan. For those living with chronic conditions being able to choose a plan that covers the prescription(s) recommended by your physician and knowing the patient cost-sharing requirements is as critical as choosing your doctor. Understanding cost-sharing structures in dollar ranges allows for consumers to make better, well-informed health insurance decisions. The Board recognizes that picking a plan that works for an individual, their family, and their budget can be difficult when accurate information is not available. Thus; we request that the formulary tool be improved to include the following elements:

- Distinguish whether drugs are covered by medical or pharmacy benefits
- Real time updates of formulary changes
- Hover over definitions of insurance terms
- Range of dollar amounts or real amount of cost-sharing requirements
- Prior authorization and step therapy information

We encourage the Board to consider the negative and long term effects that choosing the wrong health insurance plan can have on an individual's or family's budget and physical well-being. We request the Board to consider the importance of the formulary look-up tool and to integrate it into the shopping experience before the next open enrollment period.

The CCC strongly supports the C4 staff and Board for their dedicated work on creating, implementing, and continually improving our health insurance marketplace. We appreciate your consideration of full integration of the formulary look-up tool to increase transparency in costs and increase customer satisfaction within the marketplace. We look forward to continuing to work together to make Connect for Health Colorado a success for all Coloradans.
