The number of Coloradans selecting a health (medical) plan through the individual Marketplace during the last open enrollment totaled 165,000. Despite the shortening of the open enrollment period by 22 days, plan selection levels stayed consistent with the prior year. For plan year 2017, Coloradans from every county in our state signed up for medical coverage through the Marketplace. Additionally, customers receiving financial assistance increased from 61% to 69% in 2018. In 2017, C4HCO helped return \$391 million to Coloradans through Advance Premium Tax Credits. Improvements were made in serving customers during the 5th open enrollment period with a 35% reduction in caller wait time and 72% of customers applying for financial assistance receiving See Schedule O for continuation.
