






	1	Availability and Functions of the Shared Eligibility Service (now two tools – a Medicaid Rules Engine and an Exchange Rules Engine)	Steady: COHBE and HCPF have agreed that the Exchange eligibility rules engine should be developed by COHBE. As a result, CGI has contracted with a team of eligibility experts to develop the rules engine.					
	2	Functionality gaps or coding errors in base system require additional development effort and/or impact operational metrics	Steady: mitigation approach implemented but we will not know full impact until later testing phases					
	3	Service center availability	Risk has increased with tightened timeframe, however there will be a COHBE call center					
	4	Availability of Federal Data Hub	Significant improvement: we are testing with the hub in May

### Update on Initial Independent Verification and Validation (IV&V) Findings

Companies hire IV&V vendors to provide a point-in-time, external, unbiased view of issues and risks associated with large scale projects. The most valuable findings come early in the project, when findings can be remediated.

Issues identified in IV&V Review	Status	Corrective Actions	Due Date
Issue 1: Integrated Project Schedule is not complete	Remediation in process	COHBE plan, including CGI integration points has been completed. COHBE PMO is working with Eventus to incorporate their milestones into the integrated plan.	4/15/13
Issue 2: Scope expansion and Change Requests to be integrated into the project schedule	Remedied	All approved change requests have been integrated into project plan.	
Issue 3: Not sufficient visibility into content of development Releases	Remedied	COHBE and CGI will be reviewing weekly builds of code from hCentive during remaining releases to reduce risk that errors are found late in the test cycle.	
Issue 4: Need for additional PMO and other project resources (both COHBE and CGI)	CGI: Remedied COHBE: Remediation in process	COHBE added dedicated PMO resource to the PMO as a result of the IV&V findings. In addition, COHBE has temporarily allocated resources to the PMO team to assist in operationalizing key PMO processes and integrate with new vendor(s). COHBE has provided these updates to the IV&V vendor and is awaiting confirmation that the COHBE issue is remedied.	4/15/13
