 To leverage "the individual income tax filing process to maximize the enrollment of eligible uninsured individuals in a health care coverage affordability program."

 (HB20-1236)

Minimum Data Set

- Guidelines for determining minimum data set
 - Actionable for C4HCO
 - E-filer ability to pre-populate
 - Ease for customer to understand and complete
 - Shared data won't discourage filers from checking box
