

Tax Time Special Enrollment Period

Your Path to Health Coverage

Potential mediums: Email and paper notice with matching content **Key content consideration:** Most people who check the box overall will likely qualify for Medicaid, based on Maryland's findings. Messaging needs to consider multiple eligibility outcomes.

Initial Outreach Letter: Special Enrollment Period

Who gets this: Anyone who files on or before April 15 (tax filing deadline) and checks the box. **Content:** There is no time limit to apply for the Special Enrollment Period. Consumer can access the SEP anytime in the year they apply.

Goal: Inform the tax filer that they can sign up for health coverage as a result of checking the box on their tax form, encourage/drive consumers to get more information about their special enrollment period on the website and ultimately, use a tool to determine where (PEAK or Marketplace) they should apply for coverage.

Who gets this: Anyone who files after April 15 and checks the box

Goal: Inform the consumer they can apply anytime for Health First Colorado and provide next steps for using our tool (Let Us Guide You) to assess eligibility and redirect them to PEAK.

Subject: Apply Now for Free or Low-Cost Health Coverage

Dear [Customer name],

When you filed your Colorado state tax return, you indicated that you are interested in finding out if you or members of your household qualify for free or low-cost health coverage.

Since you filed your taxes after the April tax deadline, you may not qualify for the 60-day Tax Time Special Enrollment Period through Connect for Health Colorado. However, you and members of your family may qualify for a different Special Enrollment Period, or you may qualify to get covered through Health First Colorado (Colorado's Medicaid program) and Child Health Plan *Plus* (CHP+).

When can I buy insurance?

You might qualify for another opportunity to enroll through Connect for Health Colorado if you experience certain changes to your income, job or family situation, known as Qualifying Life Change Events. People who don't qualify for Medicaid and experience Qualifying Life Change Events can sign up for a health insurance plan during a 60-day Special Enrollment Period.
