I. Welcome & Introductions

II. Implementation Update

Staff briefly reviewed the process for Easy Enrollment customers and the status of each deliverable item.

Next steps include to complete testing of the Easy Enrollment Letter from the Marketplace, the ability to grant Tax Time Enrollment Special Enrollment Period (SEP), and the ability to provide Tax Time Enrollment SEP information to issuers. End-to-end testing is scheduled for December 2021 and the go-live date is on track for January 2022.

III. Tax Time Enrollment WordPress Page

Staff presented the <u>Tax Time Enrollment webpage</u> to the Committee. The webpage went live on December 5, 2021 and is available in both English and Spanish. The prior feedback by stakeholders was considered and implemented by Connect for Health Colorado.

IV. Overview of Outreach Plan

Staff shared an overview of the Marketing, Communications, and Outreach plans. The overview included:

- Marketing, Communications, and Outreach goals that align with the law.
- Maximizing awareness around the ability to receive free or reduced cost healthcare, potential partnerships, that Easy Enrollment is an option offered, and the number of people who check the box.
- The Easy Enrollment Process timeline
- Outreach efforts and strategies with assisters, brokers, enrollment centers, community partners, and e-filing organizations.

V. Tax Help Colorado

Connect for Health Colorado will continue to partner with the Tax Help Colorado team, many customers seem to overlap and benefit from services provided by both organizations. The Marketplace will provide training materials to Tax Help Colorado volunteers and will partner on a communication campaign towards the end of Open Enrollment.
