# Policy Committee Minutes June 22, 2020 1:00 PM – 3:00 PM

#### I. Welcome and Introduction

Sharon O'Hara chaired the Policy Committee Meeting and called the meeting to order at 1:00 p.m., welcoming everyone in attendance, both in-person and on the phone.

The May Committee Meeting minutes were reviewed and approved.

## II. Legislative Update

Staff provided the Committee with a legislative update. Due to Covid-19, the Legislature was faced with a three-billion-dollar revenue shortfall. This shortfall resulted in a new budget with multiple budget cuts. HB 20-1008, the health care cost-sharing arrangement, was one of the bills supported by the exchange and effected by the budget cuts, causing it to "die on the calendar".

The following bills supported by the exchange were passed through the Legislature:

- HB20-1236 Health Care Coverage Easy Enrollment Program
- SB 20-215 Health Insurance Affordability Enterprise

#### III. Strategic Goal #3 Metrics

The Committee reviewed a <u>presentation</u> on strategic goal #3, to improve the ability of customers to attain and retain the right coverage for their need, metrics in order to initiate discussion.

### IV. HCPF Update

Staff at the Colorado department of health care policy and financing (HCPF) shared a <u>presentation</u> on the Medicaid, CHP+ membership surge forecast. There is an expected membership surge of more than 500,000 Coloradoans this coming fiscal year. When the public health emergency period ends, HCPF projects an estimated disenrollment of more than 300,000 members who do not meet eligibility criteria. Communications specific to individuals coming off Medicaid will be put in place to direct them to the exchange.

### V. DOI Update

Staff at the Division of Insurance (DOI) provided an update to the Committee. The DOI will be working to appoint the enterprise board that will be seated by October 1, 2020. The DOI is entering into rate filing season with a timeline of October being the rate release.

The Committee reviewed a <u>presentation</u> on Policy agenda updates. The Policy agenda builds upon the vision set in the Policy agenda principles which exemplify the values of the organization and serve as the paradigm through which we view progress toward improving healthcare access and affordability in Colorado. The presentation highlighted background, guiding principles, priorities, progress, and proposed future Policy focus.

- There is no material governance impact on C4HCO's Board from outside interests
