I. Business Agenda

II. Board Report

Clair Brockbank provided an update on Board transitions:

III. CEO Report

Chief Executive Officer, Kevin Patterson, led a brief Board discussion regarding American Rescue Plan (ARP) subsidies. A continuation of the subsidies has not been passed by Congress. Connect for Health Colorado will continue to monitor timeline updates from Congress.

Current Special Enrollment Period

Kevin Patterson shared a graphic of current special enrollment periods (SEPs) in 2022.

Planning for the End of the PHE

The public health emergency (PHE) is anticipated to extend through July 2022. Staff is currently reviewing new guidance provided by Centers for Medicare & Medicaid Services (CMS).

Easy Enrollment

Staff presented an update on <u>Easy Enrollment</u>. The Easy Enrollment process, also known as Tax Time Enrollment, has been implemented and is available for all tax filers. The presentation outlines implementation updates, communications, media and outreach efforts, and enrollment updates.

IV. Finance & Operations

Approve Carrier Assessment Fee for FY23

The Board reviewed the <u>issuer user fee recommendation</u> for plan year (PY) 2023. The recommendation is to maintain the current structure of 3.5% of premiums on plans issued through the Exchange for PY 2023. The presentation also included information on comparable state-based exchange's (SBE's) fee structure and funding.

The Finance & Operations Committee motioned to recommend the approval of the plan year 2023 issuer user fee. Dick Thompson seconded the motion.

V. Policy Committee

2022 Legislative Session

Staff presented a <u>State Legislative update</u>. The presentation included updates on the current general session, frequently asked policy questions, current iteration of <u>Senate Bill 22-081</u> (SB22-081), and <u>House Bill 22-1269</u> (HB22-1269) for Board consideration.

Staff recommends the Board to take a support position for HB22-1269. The lack of transparency around cost sharing arrangements creates customer confusion and results in prospective Connect for Health Colorado customers buying non-Affordable Care Act (ACA) compliant plans. Increasing transparency around these entities better informs Coloradans about these arrangements and increases education and awareness about Qualified Health Plans (QHPs).

Annie Lee motioned for the Board to take a support position on HB22-1269. Christy Blakely seconded the motion.

Ms. Brockbank called for public comment.
