Current Special Enrollment Period

The Health Insurance Affordability Enterprise (HIAE) Board is working closely with the Division of Insurance (DOI) to discuss upcoming implementation and policy making.

Planning for the End of the PHE

Chief Executive Officer, Kevin Patterson, attended the Driving Innovation Across States conference held by Princeton University. The conference provided insight and <u>resources</u> for the end of the public health emergency (PHE). The PHE is anticipated to extend through July 2022.

2022 Legislative Session

Staff presented a <u>State Legislative update</u>. The presentation included updates on <u>Senate Bill 22-081</u> (SB22-081) and <u>House Bill 22-1269</u> (HB22-1269), as well as the introduction of <u>House Bill 22-1289</u> (HB22-1289) "Cover all Coloradans" for Board discussion and consideration.

Staff recommends the Board to take a monitor position for HB22-1289. While there are aspects of HB22-1289 that directly affect Connect for Health Colorado and its consumers, it is a broad bill with several other provisions. Staff will continue to monitor amendments and operational impacts as it moves through the process.
