OMNISALUD PROGRAM - TOO GOOD TO BE TRUE or just a WELL PACKAGED TRAP FOR HUMANS ??????

Dear Committee Members,

This is to express some concerns about the legality of the OMNISALUD program that you have launched and the consequences that enrollees in this program may face now or in the near future.

Every Omnisalud enrollee had to initiate his/her application by marking the "option" to share personal information with Colorado Connect and also to agree with Terms of Use and Privacy Policy. (Re snip below)

I want to share my information with Colorado Connect, a partner of Connect for Health Colorado that provides health insurance options for people who are **undocumented**. I agree to the Colorado Connect [Terms of Use](#) and [Privacy Policy](#).

Can C4HCO explain the definition of "UNDOCUMENTED PEOPLE" as it is used for Omnisalud? Are **DACA recipients** that carry lawfully issued Work Authorization, lawfully issued Social Security Number, lawfully issued driver's license and/or travel document(s) and/or who regularly file US Income Tax Returns considered to be "**undocumented**" by Connect for Health Colorado staff and committee members?

Was OMNISALUD Program really designed to help immigrants with DACA status who do not qualify for health insurance under ACA?

Has any Connect for Health Colorado staff or board member ever thought how "GREAT" it may feel be to be called "UNDOCUMENTED" after obtaining all necessary documents to work and live in this country?

How this message from C4HCO websites may read then? (Re text in bold font below)

"You are in good hands with Colorado Connect"

The OmniSalud program is a safe option because you'll be shopping and enrolling through Colorado Connect, our new, secure online platform."

"We may share personally identifiable information with third parties to cooperate with government requests, court orders, subpoenas, or legal process; if required by law;"
